

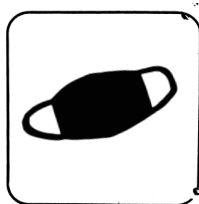

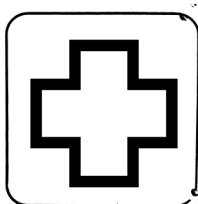
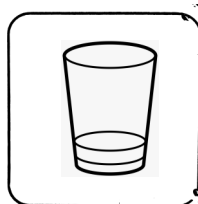


Influenza, COVID-19, RSV and Cold Season

As colder weather approaches and we spend more time indoors, the likelihood of contracting contagious diseases increases. In order to protect yourself and others, take safety precautions such as washing your hands frequently, masking when you are sick, and getting vaccinated. The CDC recommends everyone getting their flu shot and a COVID-19 booster this year. For older adults, an RSV vaccination is available and may help prevent serious illness. If you do become ill, take care of yourself by resting, eating and drinking well, and if necessary, seeking medical attention. Insurance - Open Enrollment

For people with employer sponsored insurance:



Most employers have an open enrollment period for coverage in the following year sometime between October and December. If you have concerns about your insurance coverage, please contact your employer's HR to find out when your open enrollment period is so you can compare coverage with other options available. Many employers automatically enroll people in coverage for the following year during open enrollment, so you'll need to contact them to opt out if you'd like to make a change. If you work at Tyson, JBS, or Whirlpool, we strongly encourage you to reach out to your case manager or Field Benefits Specialist for assistance with a plan comparison, as these plans have problematic limitations around filling HIV medications.

ADAP-sponsored insurance (now BDAP, Benefits and Drug Assistance Program):

Please plan to be in touch with your case manager or Field Benefits specialist in November 2023 for assistance re-enrolling in your coverage for next year. Please be sure to let us know if your income or family circumstances have changed so we can evaluate other options.



Medicare Information:



Medicare Part D open enrollment runs from October 15-December 7. Field Benefits Specialist Eliza Rose is available to assist with plan comparisons to be sure you are in the lowest cost plan with the best coverage. Eliza can offer in person Open Enrollment assistance in the Med Specialty Clinic. Please contact her at 319-335-7449 to schedule an appointment.

Important Medicare supplement information: It's very important to choose your Medicare supplement wisely. After your initial open enrollment period (at age 65 or when you end employer coverage after 65) you will not be "guaranteed issue" for a supplemental policy. This means that companies can decline your coverage based on your health conditions or charge you a significantly higher price. If you choose a Medicare Advantage plan, your coverage network may be limited and you may have higher and less predictable out of pocket costs. You may not be able to return to a supplement from a Medicare Advantage plan. Please contact your Field Benefits Specialist for help making these important coverage decisions.

For those nearing age 65: You have three months before and three months after your 65th birthday to sign up for Medicare coverage. If you do not choose to do so and can't show proof of other coverage (i.e. employer coverage from you or a spouse) you may face a lifetime premium penalty for not signing up during your initial enrollment period. This means that you will pay more every month for coverage. Please don't miss this important enrollment window!

Article: Iowa tops nation in HIV viral suppression outcomes

In a report released in May 2023, the Centers for Disease Control and Prevention (CDC) recognized the state of Iowa for having one of the highest percentages of HIV viral suppression in the country, which allows people living with HIV to reach their best health outcomes. People who sustain an undetectable viral load for at least six months also can not transmit HIV to their partners, a model known as Undetectable = Untransmittable, or U=U.

In the report, national trends show that states average 65.9% of their populations of people living with HIV achieve viral suppression, whereas Iowa reaches significantly beyond the average at 81.7%. Only one other state in the country has reached 80%, pushing Iowa to the forefront of effective HIV patient care.

The Iowa Department of Health and Human Services (HHS) Center for Acute Diseases Epidemiology writes of the report, “This is a great achievement for the state, and reflects a number of factors, including . . . consistent leadership over many years at the state and local levels.”

One of these leaders is Jack Stapleton, MD, professor in Infectious Diseases and of Microbiology and Immunology, and director of the HIV/AIDS Clinic at University of Iowa Health Care, which is now finishing its 35th year. Stapleton credits “the great team we have in our clinic” for the superlative national results. “Our staff – including physicians, physician assistants, social workers, nurses, data managers, and more – provide patient-focused care, which earns patient trust. Thanks to our grants, we can additionally provide a variety of support resources to assist with the medical care of these people living with HIV infection.”



He also credits the “great funding” received through the Ryan White HIV/AIDS Program Legislation, or the Ryan White Program. The Ryan White Program is the third largest source of federal funding for HIV care in the country after Medicare and Medicaid. Stapleton noted that three other clinics in Iowa also receive funding from the program.

The Virology Clinic at University of Iowa Health Care serves more than 25% of Iowans living with HIV, and offers a multidisciplinary approach to patient care, utilizing funds from the state-level program. This approach includes specialty pharmacists, psychiatry and social services, satellite health clinics, and housing services to comprehensively offer people living with HIV the highest rate of preferred outcomes in the state of Iowa.

How much do you know about voting?

People who are eligible to vote can vote in federal, state, and local elections. General voting eligibility guidelines are being a U.S. citizen, being 18 years old (you can register at age 17 if you will turn 18 before election day) and being registered to vote (<https://www.usa.gov/who-can-vote>). However, some eligibility guidelines vary by state. In Iowa, people with felony convictions were previously barred from voting. This law was changed in 2020 by Executive Order 7 (EO7). The voting restoration applies to people who have completed their felony sentence as of August 5, 2020, including probation or parole. Please note that there are a few exceptions to the law for those convicted of homicide. People with disabilities may receive the needed assistance to vote. If you can't leave your home, you may request an absentee ballot by printing a request form from sos.iowa.gov. You may also choose to request an absentee ballot if this is a more convenient voting option for you, regardless of disability. If you need help filling out your ballot at the poll you may choose a person, including your legal guardian, to assist you or you can use the voter assist terminal (<https://sos.iowa.gov/disabilities.html>).

You may register to vote online on the Iowa Dot Iowa online Voter Registration website or by submitting a Voter Registration Form to your local County Auditor. 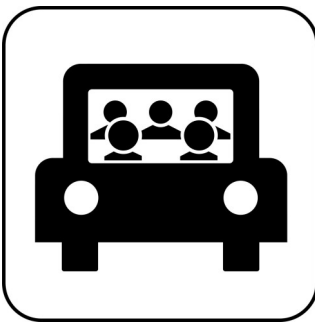




Staffing Changes: Farewells

Data Corner

In our last newsletter, we discussed how the rate of patients keeping their appointments in our clinic had risen slightly, but also highlighted the need for this trend to continue to free up valuable slots to see our providers. We worked hard to contact patients and/or their case managers prior to their appointments to provide reminders, assist with transportation in certain cases, and to help with re-scheduling visits when conflicts come up. This quarter, we're excited to report that our efforts to reduce missed appointments have paid off.

In July, August, and September, 428 patients saw a provider in our clinic, with a missed appointment rate of just 10.3%. In each of the three months, the rate was below 12%, the first time this has happened since we began tracking it in 2017. While we know we still have room to improve, this speaks to the incredible work being done by our team, and by our patients, to help our clinic operate smoothly and ensure that everyone can be seen by their provider when they need to. We're grateful to everyone who made this improvement happen.

To sustain this success over the winter months, when bad weather can lead to additional complications, we continue to ask our patients to get in touch with our program at 319-335-7520 if they have any concerns about whether they can attend their appointments, and to let us help them access care at the University of Iowa Hospitals and Clinics.

Get energy assistance to reduce your heating costs!

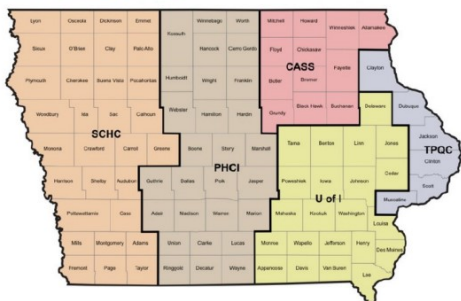
The LIHEAP program offers financial assistance to offset high winter utility costs for those households under 200% of the federal poverty level (\$27,180 annually for a household of one). This program is available to both homeowners and renters who pay heating costs. If approved, payments are made as a lump sum directly to your utility company. For homeowners, weatherization assistance to make your home more energy efficient may also be available. LIHEAP begins accepting applications on November 1, or October 1 for households with members who are over 60 or disabled.

HOPWA (Housing Opportunity for People with AIDS)

Are you in need of financial assistance to get or maintain housing? You may be eligible for services provided by HOPWA such as Long-Term Rental Assistance or Short-Term Rent, Mortgage and Utility Assistance. Permanent Housing Place-

ment Services may be able to provide your rental security deposit and/or first month's rent. Eligibility is based on your income and limits vary by county. CLEAR (Choosing Life, Empowerment, Action and Results)



CLEAR is a program open to those living with HIV interested in increasing or enhancing behaviors that support a healthy life. The program specializes in topics such as medication adherence, disclosure of HIV status, managing sexual risks and self advocacy in health care, but the program is personalized to fit your needs and wants.
